**Interconnection Agreement between Teliix, Inc. and Consolidated
Communications of Northern New England Company, LLC**

**Order Granting Motion to Establish New Publication Deadline for
Compliance with Order No. 27,007**

O R D E R N O. 27,030

July 3, 2024

On May 13, 2024, the Commission issued Order No. 27,007, an order *nisi* approving an interconnection agreement between Teliix, Inc. and Consolidated Communications of Northern New England Company, LLC (Consolidated). The order required Consolidated to post a copy of the order on its website by May 17, 2024. The order stated that it would take effect on June 13, 2024, unless an interested party filed an objection, Consolidated failed to comply with the publication deadline, or the Commission ruled otherwise in a supplemental order.

On July 1, 2024, Consolidated filed an assented to motion to reset the interconnection agreement approval and effective dates due to Consolidated's failure to timely post a copy of the order on its website. As a result of its inadvertent error, Consolidated did not publish a copy of the order by the May 17, 2024 deadline and therefore the order did not go into effect on June 13, 2024. Consolidated now requests that the Commission establish a new publication deadline.

Based upon the foregoing, it is hereby

ORDERED, assented to motion to reset interconnection agreement approval and effective dates is **GRANTED**; and it is


FURTHER ORDERED, that Consolidated Communications of Northern New England Company, LLC shall post copies of both Order No. 27,007 and this order on its website no later than July 9, 2024, to be documented by affidavit filed with the Commission by July 11, 2024;


FURTHER ORDERED, that all persons interested in responding to Order No. 27,007 be notified that they may submit their comments or file a written request for a hearing which states the reason and basis for a hearing no later than July 18, 2024, for the Commission's consideration; and it is


FURTHER ORDERED, that any party interested in responding to such comments or request for hearing shall do so no later than July 29, 2024; and it is

FURTHER ORDERED, that Order No. 27,007 and this order shall be effective August 2, 2024, unless Consolidated Communications of Northern New England Company, LLC fails to satisfy the publication obligation as set forth above or the Commission provides otherwise in a supplemental order issued prior to the effective date.
